1.0 Study Highlights

More than one parent out of twenty admitted to having inflicted painful corporal punishment on their children.

2.0 Results

2.1 More than one parent out of twenty admitted to having inflicted painful corporal punishment on their children


5.6% of Canadian parents admit that they themselves or their spouse have already inflicted painful corporal punishment on their children. This percentage can be broken down as follows: 2.8% have inflicted painful corporal punishment, 2.1% have had recourse to painful corporal punishment with an object and 0.7% have administered painful corporal punishment having led to injury to the child.

It is good to note, however, that parents aged 45 years and under are less likely to use painful corporal punishment. In fact, for all of these types of punishments, the percentage is 3.2% for parents 45 years old and under and 12.9% for those above 45 years of age.

We note that 50.4% admit to inflicting light corporal punishment. However, the study found that 9.7% of those persons also inflict painful corporal punishment to their children.

Although a significant difference was found between parents under 45 and those over 45 in terms of painful corporal punishment, the difference was much less significant when it came to violent language directed toward children. In fact, the rate is 9.1% for those under 45 and 11.5% for those above 45.

Note: The total on the vertical axis may exceed 100% since respondents may have answered "yes" in more than one category.

Moreover, if 70.6% of Canadians reprimand their children, we also note that 33.6% of parents strongly reprimand them and 10.5% speak to them in a violent manner. Among those who admitted speaking violently to their children, 26.2% also inflict painful corporal punishment upon them.

Let us mention that there were no significant differences between men and women in terms of the language used to speak with children and the corporal punishment inflicted upon them.



2.2 More than two parents out of ten having received abusive corporal punishment as children do or did the same thing to their own children

21.6% of parents who mentioned having received abusive corporal punishment as children inflict or inflicted upon their own children the same type of treatment. 2.4% of Canadian parents mentioned having <u>regularly</u> received painful corporal punishment as children and 26.9% do the same thing to their own children. In the case of the 11.8% of Canadians who received this type of punishment <u>occasionally</u>, 20.5% give or have used the same type of punishment with their children on occasion as well.

We note that among the 70.7% of Canadians who were slapped as children, 87.5% slap or slapped their own children.

We also noticed that 27.1% of parents who speak or spoke to their children in a violent manner had been treated in the same way during their childhood.

2.3 Opinions are mixed when it comes to determining whether a light slap is an effective way to make a child think

46.9% of the Canadian population feels that a light slap is an effective way to make a child think while 46.6% do not share this view.

51.4% of men, 61.6% of those 55 years old and over, 52.0% of manual workers and 52.1% of those not in the labour force were more likely to be in favour of the light slap.

In that respect, 21.9% of Canadians believe that the government should pass legislation to prohibit parents from spanking their children while 70.0% mentioned being opposed to such a law.

24.4% of women, 27.9% of those 18 - 24 years old, 39.1% of Francophones, 37.5% of Quebeckers and 34.0% of those in the lower income brackets were more likely to be in favour of such a law.

Moreover, 79.9% of Canadians would be in favour of creating an easily remembered telephone number, much like 911, that would enable children to obtain information on their rights or assistance if they were being mistreated. This system exists in Scandinavian countries and in many European countries.

3.0 Methodology

This study was conducted by Leger Marketing through telephone interviews among a representative sample of 1516 English- or French-speaking Canadians, 18 years of age or older.

The interviews were conducted from our Montreal and Winnipeg call centres between January 22 and January 27, 2002. Up to ten call-backs were made in the case of non-response.

Using data from Statistics Canada, the results were weighted according to geographic location, gender and language spoken at home to ensure a sample representative of the entire Canadian adult population. In the end, the maximum margin of error obtained for a sample of 1516 respondents is of \pm 2.6%, 19 times out of 20.
